Get to know your Berkeley County Sheriff

Duane Lewis began his law enforcement career in 1984 at the Berkeley County Sheriff's Office as a Deputy.

In 1987, Lewis became a Patrolman with the City of Charleston Police Department. While there, he obtained the rank of Investigator. In 1991, He became a Special Agent for I.N.S. Investigations Bureau, a national arson investigative unit for the insurance industry. Lewis was hired as a Detective at the Goose Creek Police Department in 1992. He was soon promoted to the rank of Detective Sergeant and supervised the Detective Division.

In 1994, he accepted a position with the South Carolina Public Service Authority (Santee Cooper) as a Special Agent in the Law Enforcement Division. He served at Santee Cooper for 22 years. During his time, he was promoted to Major and later Deputy Chief. Lewis was responsible for Criminal Investigations, Training and Development, Internal Investigations, and Federal Regulatory Regulations. He served as a member of the National Homeland Security Critical Infrastructure Coordinating Council after the terrorist attacks in 2001.

In June of 2015, Duane Lewis was elected as the Sheriff of Berkeley County. He was re-elected in 2018 and 2022.

Sheriff Lewis is a graduate of Goose Creek High School and has a Bachelor of Arts degree from Columbia College.

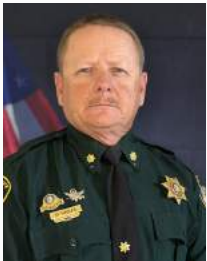
BERKELEY COUNTY SHERIFF'S OFFICE SENIOR COMMAND STAFF



Chief Deputy Baker is second in command at the Berkeley County Sheriff's Office and acts on behalf of the Sheriff in his absence. He is responsible for the day-to-day operations of the Sheriff's Office, develops and oversees the Berkeley County Sheriff's office budget, and manages and coordinates the various divisions within the Sheriff's Office.



Major Willie Hickman commands the Operations Branch of the Sheriff's Office which includes the North and South Uniform Patrol Districts, the North and South Community Action Team members, Court Security, Warrants, Civil Process, Judgments, and the U.S. Marshal's Task Force.



Major Bobby Shuler commands the Investigations and Support Services Branch of the Sheriff's Office which includes: Criminal Investigations, Drug Enforcement Task Force, Forensics, Crime Analysis, Sex Offender Registry, Victim Advocates, Internet Crimes Against Children, Computer Forensics, Pawn Shop Investigations, Civil Disturbance Team, K9, Traffic Unit, Marine Patrol, Search and Rescue Team, Dive Team, Special Response Team, Bike Unit, Records, School Resource Officers, Duty Office, Animal Control, and LE Explorers.



Director Randy Demory serves as the Director of the Detention Center. Director Demory is a nationally recognized detention professional with 40 years of experience in the corrections field.



Inspector Dan Isgett commands the Office of Professional Standards. The Office of Professional Standards is responsible for Internal Affairs, Grants, National and State Accreditation, Recruitment, Polygraph & Background Investigations, Planning and Research, Emergency Operations, BCSO Awards, Peer Support, Promotional Processes, and Accident Review.



Major Anthony Phyll is the Operations Commander at the Hill-Finklea Detention Center. He is responsible for inmate supervision, The Special Operation Response Team, Transport, and Litter pick-up.

BERKELEY COUNTY SHERIFF'S OFFICE ANNUAL AWARDS

DEPUTY OF THE YEAR 2023

Corporal Bernard "BJ" Nelson. Cpl. Nelson has been a valuable member of the Sheriff's Office since 2018. He consistently demonstrates the attributes that all law enforcement officers should strive to possess to be effective in this profession. Cpl. Nelson manages his time well and is proactive with his K9 partner, Kai. Cpl. Nelson and Kai have become a very successful K9 team and have an excellent tracking record, which is well above the national average.



SUPERVISOR OF THE YEAR 2023

Sergeant Joe Seegars. Sergeant Seegars has been a valuable member of the Sheriff's Office since 2015. He is actively involved with the development, execution, and evaluation of in-service and advanced training for all deputies. He is a team leader on the Special Response Team, supervisor over the K9 Unit, and for most of 2023, was also responsible for supervising North Night Team 1 as its sergeant.



RESERVE DEPUTY OF THE YEAR 2023

Reserve Deputy Nathan Whitten. Reserve Deputy Whitten began his service with the Sheriff's Office in September 2022. Reserve Deputy Whitten quickly reached Level 4 with the Sheriff's Office which qualifies him to patrol on his own, respond to and answer calls for service, and make criminal and traffic cases. Over the course of the year, Reserve Deputy Whitten logged over 434 hours of service to the Sheriff's Office.



CIVILIAN OF THE YEAR 2023



Mrs. Linda Brown. Linda Brown has been an employee with BCSO since 2015. Since her assignment as Grants Specialist, the Berkeley County Sheriff's Office has been awarded grants totaling \$6,653,002. In 2023, the Berkeley County Sheriff's Office was awarded eight grants totaling \$3,224,395. The grants awarded were: DUI Enforcement Grant, DUI Prosecutor Grant, Traffic Safety Grant, Traffic Overtime Grant, JAG Allocation Grant, VOCA Grant, SRO Grant, and the Port Grant. Linda Brown wrote and manages these grants which fund the salaries and benefits of 20 Berkeley County Sheriff's Office employees.

DETENTION DEPUTY OF THE YEAR 2023

Detention Deputy Avery Smith. PFC Smith has been a valuable member of the Detention Center since 2022 and has assumed additional duties to include being on the Special Operations Response Team as well as the Sheriff's Office Civil Disturbance Team. In 2023, PFC Smith consistently demonstrated attributes desired of the ideal detention deputy. On October 3, 2023, during an assigned hospital duty at Trident Medical Center, PFC Smith overheard on the radio that an inmate was attempting to escape detention. The inmate had assaulted another detention deputy and was able to flee the hospital into the parking lot. PFC Smith immediately sprang into action, pursued the inmate on foot, and brought him back into custody. PFC Smith's quick response ensured the continued safety to the public and saved many resources that would have been expended had a manhunt ensued.



DETENTION SUPERVISOR OF THE YEAR 2023

Lieutenant Kansas Daab. Lt. Daab has been a valuable member of the Detention Center since 2009. Lt. Daab oversees a Detention Center squad and, in addition to administrative duties, also assists with day-to-day operations of the detention center. Lt. Daab's attentiveness to duty has prevented large amounts of contraband from entering the Detention Center.

DETENTION SUPERVISOR OF THE YEAR 2023

Sergeant Christopher Dozier. Sgt. Dozier has been a valuable member of the Detention Center since 2016. Sgt. Dozier oversees one of the squads and, in addition to administrative duties, also assists with day-to-day operations of the Detention Center. In 2023, Sgt. Dozier has consistently demonstrated attributes desired of a supervisor. Sgt. Dozier's attentiveness to duty has prevented large amounts of contraband from entering the Detention Center.



DETENTION CIVILIAN OF THE YEAR 2023

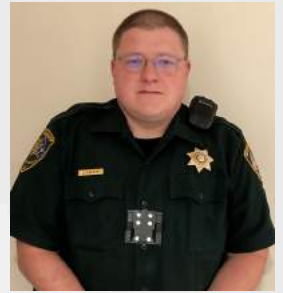

Ms. Boris' willingness to learn new roles has improved inmate bookings, public relations, the release of inmate property, as well as many other areas.



BERKELEY COUNTY SHERIFF'S OFFICE QUARTERLY AWARDS

DEPUTY OF THE 1ST QUARTER

Corporal Joshua Babson. Deputy Babson's proactive approach to patrolling high crime areas, particularly after major incidents such as homicides, has been instrumental in maintaining public safety. On multiple occasions, Deputy Babson demonstrated exceptional skill, and commitment to law enforcement and the public by locating suspects, vehicles, and weapons related to these incidents. These efforts provided Detectives with vital information crucial for the successful prosecution of suspects.



DEPUTY OF THE 2ND QUARTER

Deputy Tyler Kittrell. Deputy Kittrell's superior conduct throughout the quarter is highlighted by his exceptional performance on April 29, 2023. Deputy Kittrell used a vehicle description and a license plate number to conduct a high risk traffic stop of a vehicle involved in an armed robbery with three suspects. He expertly assessed the situation and conducted the traffic stop with precision. Despite the inherent risks, he managed to detain the driver, without any further incident.



DEPUTY OF THE 3RD QUARTER

Corporal Bernard "BJ" Nelson: During the quarter, Cpl. Nelson successfully tracked four suspects, three of which were armed and involved in violent crimes. Cpl. Nelson has distinguished himself by being a Field Training Instructor and can often be found training new deputies. Cpl. Nelson is very knowledgeable and junior deputies often look to him for advice and guidance. During the quarter, Cpl. Nelson was also able to make 20 proactive arrests for illegal drugs, firearms, and of wanted persons.



DEPUTY OF THE 4TH QUARTER

Corporal Wallace White and Deputy Robert Bailey. Cpl. White and Deputy Bailey's superior conduct throughout the quarter is highlighted by their exceptional performance on November 29, 2023. The deputies responded to a call in relation to a person armed with a knife who was believed to be having a severe mental health crisis. Corporal White and Deputy Bailey worked together to engage the person in a dialogue and created a meaningful rapport and persuaded him to disarm and go to a hospital for treatment.

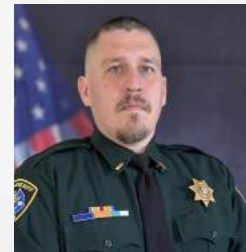

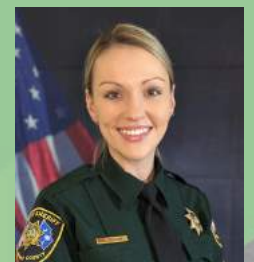

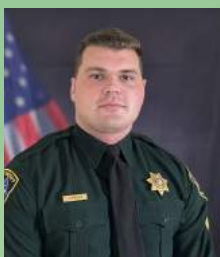

BERKELEY COUNTY SHERIFF'S OFFICE DUI PROSECUTOR

We are excited to welcome attorney Camille Weal-Thomas as the Berkeley County Sheriff's Office DUI Prosecutor. The Berkeley County Sheriff's Office DUI Prosecutor position is funded by a grant from the South Carolina Department of Public Safety. The DUI Prosecutor reviews and prepares all pending alcohol and drug-related driving arrest charges made by Berkeley County Sheriff's deputies for magistrate court. Previously, Berkeley County deputies prosecuted their own cases in magistrate court without the assistance of legal council and regularly contended with experienced DUI defense attorneys.



A native of Camden, New Jersey, Camille graduated from Rowan University in 2015 with a bachelor's degree in law and justice. Prior to law school, Camille was enlisted as a Military Police Officer in the United States Navy in Kings Bay, Georgia specializing in strategic asset protection for a Security Force Battalion.

Camille graduated from the Charleston School of Law in 2022 in the top 25% of her graduating class earning a Juris Doctor degree. During law school, Camille was a proud member of the Black Law Students Association, assisted indigent members of the Charleston community facing evictions in housing court, and helped indigent clients file tax returns with the Charleston Urban League.

Prior to working with the Berkeley County Sheriff's Office, Camille worked in the private sector as a personal injury attorney and Camp Lejeune toxic tort administrator.

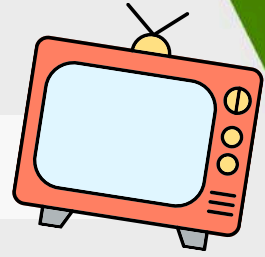

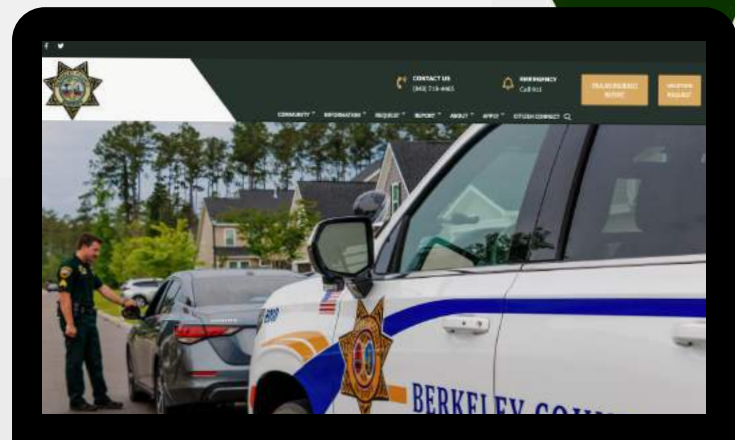

WHAT'S NEW AT BCSSO?

BCSSO NEW MOTOR UNIT

The Berkeley County Sheriff's Office has created a Motor Unit in the Traffic Services Unit. Four deputies will be assigned to the Motor Unit. Deputies assigned to the Unit must successfully complete 80 hours of training and an additional 80 hours with a field training deputy before they can operate on their own.

Motor Unit deputies will participate in traffic enforcement, funeral and VIP escorts and various duties as assigned. Deputies assigned to the Motor Unit will operate 2023 Harley Davidson police motorcycles.



BCSSO NEW PUBLIC SAFETY UNIT

Berkeley County Sheriff Duane Lewis is pleased to announce the creation of the Public Safety Unit at the Berkeley County Sheriff's Office. The mission of the Sheriff's Office is "Taking Care of People". This unit was created with that vision in mind.



"Our county is continuously growing, and with growth comes new demands." Berkeley County Sheriff Duane Lewis stated. "The purpose of the Public Safety Unit is to assist our citizens with a variety of calls for service quickly and efficiently. The use of the Public Safety Officers will allow deputies to remain available for more serious incidents."



The increase of Berkeley County's population increases the number of traffic-related incidents. The Public Safety Unit will be patrolling the roadways seven days a week, with the goal of reducing traffic hazards in mind. Each service truck assigned to a Public Safety Officer is fully equipped to assist motorists. Public Safety Officers can assist with a variety of issues including traffic control and direction, changing flat tires, disabled motorists, and vehicle lockouts. Each Public Safety Officer is also an Emergency Medical Technician that can render on-scene medical assistance until the arrival of EMS. Public Safety Officers are also trained to take basic incident reports so that deputies are available to handle serious incidents and crimes in progress.

The creation of the Public Safety Unit is another example of the many ways the Berkeley County Sheriff's Office is committed to taking care of people by keeping them safe in the community.

BERKELEY COUNTY SHERIFF'S OFFICE UNIFORM PATROL DIVISION

UNIFORM PATROL

The Uniform Patrol Division provides 24 hour coverage, seven days a week. Deputies are assigned to permanent 12 hour shifts led by a shift Sergeant and Lieutenant. Deputies are assigned to patrol zones which are divided between the South and North areas of the county. In 2023, patrol deputies responded to 118,669 calls for service.



COMMUNITY SERVICE

The Berkeley County Sheriff's Office is committed to our partnership with the Berkeley County community. Sheriff Lewis and members of the Berkeley County Sheriff's Office continually meet with the citizens of Berkeley County to listen to their concerns and work together to address issues effecting their lives.



COMMUNITY ACTION TEAM

The Community Action Team (CAT) has been successfully developing relationships with community leaders across Berkeley County. CAT members are assigned to specific areas of the county and work together with community leaders to address concerns.

In 2023, CAT members made 1,177 business contacts, 69,892 public contacts, attended 44 Crime Watch meetings, and attended over 1,481 community events. They handled 1,146 calls for service, issued 38 citations and 154 warnings.



BERKELEY COUNTY SHERIFF'S OFFICE JUDICIAL SERVICES DIVISION

THE COURTS

Berkeley County Sheriff's Office Court Security is comprised of both full duty and limited duty deputies. The Berkeley County Courthouse is open Monday through Friday from 9 AM to 5 PM, except for holidays. During any given week, there are approximately 1,000 to 2,000 people that enter the Courthouse for various reasons. There are six courtrooms located in the Courthouse: two full-time Family Court courtrooms and the remaining courtrooms are used for General Sessions (Criminal), Common Pleas (Civil), Probate Court, and the Master-in-Equity. Occasionally, all six courts will be in session simultaneously.



Court Security Deputies are tasked with maintaining the peace and protecting the citizens, court staff, attorneys, and judges. Court Security Deputies are also responsible for managing adult inmates and juveniles that are brought into the courtrooms. In addition to the required training all deputies receive each year, deputies assigned to Court Security also receive specialized court security training. In 2023, there were 1,190 sessions of court requiring a deputy. Additionally, 110 adults arrested, and eight juveniles were detained.

WARRANTS & CIVIL PROCESS

The Warrants / Civil Process Unit is responsible for serving criminal arrest warrants, family court warrants, and summary court bench warrants. The Warrants/Civil Process Unit also serves jury summons, assists with foreclosures, and serves a variety of civil court documents. In 2023, 2,235 warrants were served and 2,172 civil process papers were served.



TRAINING UNIT



The Berkeley County Sheriff's Office Training Unit is responsible for coordinating and conducting training for all LE-1, LE-2, and LE-3 Berkeley County Sheriff's Office personnel. They also help train Detention Deputies, Reserve Deputies, Special Deputies, Retirees, and Auxiliary Personnel. The Training Unit coordinates with the South Carolina Criminal Justice Academy (SCCJA) to ensure that Berkeley County Sheriff's Office personnel have required basic law enforcement training as well as advanced training. The Berkeley County Sheriff's Office Training Unit also provides training for other local law enforcement agencies in Berkeley County.

In 2023, the training unit conducted three, 12-hour block training classes for sworn deputies. This includes annual firearms qualifications, vehicle operations, and other mandatory in-service training.

The Forensics Unit is responsible for crime scene processing, all in-custody property, and the processing of evidence. A Lieutenant, Sergeant, and three technicians are available 24/7 to respond to incidents. Members of the Unit are trained in crime scene processing, blood spatter analysis, photography, and latent processing.

SEX OFFENDER REGISTRY



The Berkeley County Sheriff's Office is required by law to conduct an annual check on all registered sex offenders in Berkeley County. The offenders must come to the Sheriff's Office to register quarterly or bi-annually depending on the type of crime they committed. The Sheriff's Office is also required to confirm sex offender's addresses annually. There are 402 sex offenders registered in Berkeley County. In 2023, the Sex Offender Registry Unit attempted 596 residency checks and completed 398 residency checks and arrested 21 individuals. Citizens can visit the Berkeley County Sheriff's Office website at sheriff.berkeleycountysc.gov, then select the information tab, select sex offender registry, and then select crime mapping at the bottom of the page, to view the locations of sex offenders and their information.

BERKELEY COUNTY SHERIFF'S OFFICE PROFESSIONAL STANDARDS

INTERNAL AFFAIRS

The Office of Professional Standards investigates serious incidents and coordinates citizen complaint investigations. The Inspector of Internal Affairs investigations reports directly to the Sheriff for Internal Affairs investigations. In 2021, the Sheriff's Office began using Guardian Tracking software to track administrative documents to including corrective action. This software also allows supervisors to provide coaching documentation.

In 2023, there were 33 citizen complaints filed by citizens either in person or online. Of the 33 complaints, seven were sustained for minor policy violations. There were eighteen Internal Affairs Investigations of which six were sustained. Some of the Internal Affairs Investigations included serious deputy involved vehicle accidents and use of force reviews.

BACKGROUND INVESTIGATIONS

Deputy Sheriff applicants must successfully pass an extensive background process including driver's license and criminal history checks, credit checks, verification of employment and education records, a reading comprehension test, a physical abilities test, a polygraph examination, and medical and psychological screening. In 2023, the Sheriff's Office received 254 applications for LEI positions. The Berkeley County Sheriff's Office hired 47 new deputies in 2023.



RECRUITMENT

In order to recruit future deputies, the Sheriff's Office attended five job fairs in 2023 and continues to maintain close contact with colleges, universities, and civic organizations. In a 2023 anonymous survey of newly hired deputies, 79% reported that the reputation of Sheriff Duane Lewis and the Berkeley County Sheriff's Office was listed as the most important/very important reason that they decided to apply to the Sheriff's Office. The Sheriff's Office has a total of 221 total sworn deputy positions. In 2023, the Sheriff's Office added six additional grant SRO positions.

BERKELEY COUNTY SHERIFF'S OFFICE PROFESSIONAL STANDARDS

ACCREDITATION

The Berkeley County Sheriff's Office is state and nationally accredited public safety organization. CALEA (The Commission on Accreditation for Law Enforcement Agencies), is the national credentialing authority that only awards Accreditation Certifications to public safety agencies that have demonstrated compliance with CALEA standards. There are currently 461 CALEA standards that apply to the Berkeley County Sheriff's Office and CALEA certification is a four year evaluation process. The Berkeley County Sheriff's Office is one of only six nationally accredited Sheriff's Offices in South Carolina and one of only 94 nationally accredited Sheriff's Offices in the United States. (Note: There are 3,012 Sheriff's Offices in the United States.) Sheriff's Offices in the United States.)

Under Sheriff Lewis' leadership, the Berkeley County Sheriff's Office is seeking their third CALEA re-accreditation award. During 2023, the Sheriffs Office successfully completed all reviews.



The Berkeley County Sheriff's Office received its sixth State re-accreditation award in 2023.

EMERGENCY OPERATIONS

The Sheriff's Office works with the Berkeley County Emergency Management Department to plan for and mitigate natural and man-made disasters. The Berkeley County Sheriff's Office updates Hurricane Response Plans annually. During hurricanes and other natural disasters, all sworn personnel are activated to ensure the safety of our residents. Deputies man traffic control points in the evacuation routes, man emergency shelters, and patrol neighborhoods and businesses during the evacuation. In 2023, deputies attended emergency operations training that consisted of table top training, in-person training, and webinars.



BERKELEY COUNTY SHERIFF'S OFFICE PROFESSIONAL STANDARDS

GRANTS

The Grants Office is responsible for developing and submitting grant applications, assisting with project planning, and budgeting and detailing performance measures. Once a grant is awarded, the Grants Specialist reviews procurement expenditures to ensure compliance and managing the submission of financial and programmatic data. In 2023, the Berkeley County Sheriff's Office was awarded eight grants totaling \$3,224,395. The grants awarded were: DUI Enforcement Grant, DUI Prosecutor Grant, Traffic Safety Grant, Traffic Overtime Grant, JAG Allocation Grant, VOCA Grant, SRO Grant, and the Port Grant. The Grants Specialist wrote and manages these grants which fund the salaries and benefits of 20 Sheriff's Office employees.



PLANNING AND RESEARCH

The planning and research function is vital to the sheriff's office to provide data and analysis to Sheriff Lewis and the Command Staff. The reports include Strategic Planning, Use of Force Analysis, Vehicle Pursuit Analysis, Recruitment Plan Analysis, Goals and Objectives, Internal Affairs Summary, Review of Grievances, Early Warning Intervention Evaluation, Bias Policing review and other research as requested by the Sheriff.



BERKELEY COUNTY SHERIFF'S OFFICE SCHOOL RESOURCE OFFICERS DIVISION

The School Resource Officer Division is a collaborative effort between the Sheriff's Office, Berkeley County School District, and Charter Schools USA to provide a deputy sheriff in all schools located in the unincorporated areas of Berkeley County. The SRO Division strives to keep campuses safe and foster positive relationships with the students and community. The SRO Division consists of 36 deputies who are assigned to five high schools, seven middle schools, 15 elementary schools, and one charter school. Deputies are often found interacting with students and staff, from providing instruction on drug and gang resistance programs to mentoring and counseling students when appropriate.



SRO deputies use teacher work days and summer break to attend advanced training classes to be better prepared to carry out their duties.

During the 2022-2023 school year, SRO deputies took 524 incident reports on school campuses, made 269 arrests and recovered seven handguns.



BERKELEY COUNTY SHERIFF'S OFFICE SPECIAL OPERATIONS DIVISION

MARINE PATROL UNIT

The Marine Patrol Unit consists of nine Boat Captains and 21 crew members. During 2023, the Marine Patrol Unit logged 97 tours of duty, 329 extra patrols, assisted 34 disabled vessels, investigated three collisions, responded to nine disturbances and assisted with four medical responses.



Between Memorial Day and Labor Day, the Marine Patrol Unit logged over 776 hours of active patrolling of the 130 sq miles of Berkeley County's waterways. The Marine Patrol Unit responded and participated in 38 rescue/recovery missions, as well as 30 security/law enforcement related missions.



DIVE TEAM

In 2023, the Dive Team consisted of nine team members: six sworn members and three auxiliary members. The team logged 300 training hours, including training with other agencies. During 2023, the Dive Team assisted with three anti-terrorism missions and had one evidence recovery mission.



RESCUE UNIT

In 2018, the Berkeley County Sheriff's Office assumed the responsibilities of marine and ground search/rescue operations from the Berkeley County Rescue Squad. In 2023, the Sheriff's Office Rescue Unit participated in 4 ground rescue/missing person searches.

BERKELEY COUNTY SHERIFF'S OFFICE SPECIAL OPERATIONS DIVISION

K-9 UNIT

The Berkeley County Sheriff's Office currently has seven handlers and seven canines in service. Five of these canines are "Patrol Dogs" and two are bloodhounds used only for tracking. In 2023, the K-9 Unit made 168 arrests, ran 98 tracks, conducted 55 searches for articles or hiding persons, seized 44 firearms, seized \$11,600, and seized one vehicle. The K-9 Unit also seized 1,100 grams marijuana, 374 grams of meth, 29 grams of heroin, and 1,115 grams of cocaine. The K-9 Unit attended twenty-five community events this year including a K-9 demonstration at the Coastal Carolina Fair. The K9 Unit also conducted searches of the Hill Finklea Detention Center, various Berkeley County High Schools, and perimeter sweeps of the Berkeley County Office building.

The Sheriff's Office K9 Unit attended the annual NAPWDA (North American Police Work Dog Association) certification workshop in 2023.



TRAFFIC UNIT



The Berkeley County Sheriff's Office Traffic Unit is comprised of one sergeant and five deputies. In 2023, the traffic unit made 149 DUI arrests which accounted for 88% of the Berkeley County Sheriff's Office DUI arrests. The Traffic Unit issued 2,149 Citations in 2023 and 3,179 Public Contact Warnings. The Traffic Unit completed 13 saturation patrols and 80 selective enforcement responses to area complaints. The Traffic Unit also connected with the community in other ways in 2023; conducting 13 safety presentations and two free car seat safety checks. Deputies assigned to the The Traffic Unit completed over 225 hours of advanced training for the calendar year.

In recognition of their efforts, the Berkeley County Sheriff's Office Traffic Unit was the first runner-up for the state at the Mothers Against Drunk Driving Award ceremony and five members of the Berkeley County Traffic Unit received the South Carolina Department of Public Safety DUI Hero award. The unit achieved one gold award, one silver award and three bronze awards from the South Carolina Department of Public Safety.

BERKELEY COUNTY SHERIFF'S OFFICE SPECIAL OPERATIONS DIVISION

ANIMAL CONTROL UNIT

The Animal Control Unit consist of five Animal Control Officers (ACOs) that answer and investigate a variety of animal service calls. In 2023, ACOs answered 5,398 calls for service in Berkeley County. 62 of those calls were bite related calls. ACOs regularly assist municipalities along with the SC Department of Natural Resources on calls for service.



MOST COMMONLY VIOLATED ANIMAL SERVICES LAWS :

No owner shall fail to provide their animal(s) or pet(s) with:

- sufficient good and wholesome food and water,
- proper shelter and protection from the weather,
- veterinary care when needed to prevent suffering,
- and humane care and treatment.

No person shall beat, cruelly treat, torment, overload, overwork, or otherwise abuse an animal, or cause, instigate, or permit any dogfight, or other combat between animals or between animals and humans.

No owner of an animal shall abandon such animal.

The owner of a dog or cat must have it inoculated against rabies at a frequency to provide continuous protection of the animal from rabies using a vaccine approved by the Department of Health and Environmental Control and administered by a licensed veterinarian.

It shall be unlawful for any owner or custodian of any pet or animal to permit same to run at large at any time upon any street or highway or other property within the County, except upon property owned or rented by the owner or custodian.

No pet or animal shall be permitted to be on school grounds or in a shopping area or similar public place unless on a leash at all times.



BIKE TEAM



The Bike Team is a collateral duty assignment consisting of eleven deputies. The Bike Team strives to improve community relations and actively patrols neighborhoods, businesses, hotels, special events, and high crime areas. Team members average between 15-30 miles during their active patrols.

BERKELEY COUNTY SHERIFF'S OFFICE SPECIAL OPERATIONS DIVISION

SPECIAL RESPONSE TEAM (SRT)



In 2023, The Special Response Team (SRT) conducted more than 96 hours of agency specialized training. SRT members attended a 30-hour course of Advance SWAT instruction taught by the Orion Training group. The SRT participated and partnered with federal, state and local law enforcement to provide on-site security/protection for the Annual 2023 Cooper River Bridge Run as well as several dignitary visits. Newly assigned members of the SRT attended a Basic SWAT course/certification conducted by the City of Charleston Police Department.

The SRT members were utilized and deployed on twelve calls for service including calls involving wanted fugitives and barricade/armed subjects. The SRT assisted federal, state, and local agencies in locating and apprehending an extremely dangerous wanted fugitive from New Jersey and Pennsylvania during a large-scale manhunt in Berkeley and Charleston Counties.

RESERVE DEPUTIES

A Reserve Deputy is a volunteer law enforcement officer that has attended all the required training and passed all the required tests as mandated by the South Carolina Criminal Justice Academy. Reserve Deputies receive the same training as full-time deputies. Training takes approximately 162 hours and spans a three month time frame. South Carolina state law requires that each Reserve Deputy maintain 60 hours of service time each quarter or 20 hours per month. They are also required to attend training once a month. In 2023, Berkeley County Reserve Deputies worked 4,528 hours. Berkeley County currently has 20 Reserve Deputies. Classes for BCSO Reserves Deputies are typically opened yearly.

LAW ENFORCEMENT EXPLORERS

Law Enforcement Explorer Post 700 is chartered by the Boy Scouts of America. Youths ages 14 to 20 are eligible to become a Law Enforcement Explorer. Law Enforcement Explorers are trained in all areas of law enforcement duties to include traffic control, crime scene investigation, patrol duties, building searches and report writing. There are currently 23 Explorers in the Sheriff's Office Post 700.



During the SCALES (South Carolina Association of Law Enforcement Explores) conference, BCSO Explorers competed in several events that involved a wide variety of law enforcement-related topics including high-risk traffic stops, drug search warrants, arrest warrants, crime scene, firearms, active shooter, mental health crisis intervention, civil disturbances, officer down scenarios, court room testimony, traffic collision reports, incident reports, an emergency operation course and a physical agility course. The Berkeley County Sheriff's Office Explorers took home several first and second place awards at the event.

BERKELEY COUNTY EXPLORER POST 700

BERKELEY COUNTY SHERIFF'S OFFICE TECHNICAL AND SUPPORT SERVICES DIVISION

The Technical and Support Services Division oversees all technical projects and equipment for the Sheriff's Office and also conducts forensic analysis of technology for criminal investigations. The Records Office and the Duty Office are included in this Division.

RECORDS UNIT

The Records Unit is staffed by a unit supervisor, three administrative support specialists, and an expungement clerk. Agency reports and documents are submitted to the Records Unit. Records personnel also are responsible for responding to Freedom of Information Act records requests as well as running criminal history checks, military-background checks, and DSS background checks. Records personnel enter warrants and protection orders, process concealed weapons permit entries and responses, enter NCIC (National Crime Information Center) validations, process Rule 5 requests, and process expungements.

BERKELEY COUNTY SHERIFF'S OFFICE HILL-FINKLEA DETENTION CENTER

OPERATIONS DIVISION

The Operations Division is responsible for the direct supervision of inmates, SORT (Special Operations Response Team), the Transport Unit, and the litter pick-up programs.

TRANSPORT UNIT

The Transport Unit is responsible for all local and out-of-state transports, to include transports to court hearings and medical facilities. Transport Unit Detention Deputies are also responsible for the security of inmates at medical facilities. In 2023, the Transport Unit conducted 1,436 transports. This included 439 juvenile transports and 182 therapeutic transports.



LITTER PICK-UP PROGRAM

In 2015, the Berkeley County Sheriff's Office instituted the Litter Pick-Up Program. Inmates meeting certain classification criteria volunteer to participate in this program. Under the supervision of detention deputies, the inmates clean up trash from the sides and medians of public roadways and other public areas.



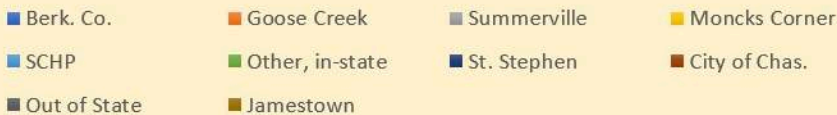
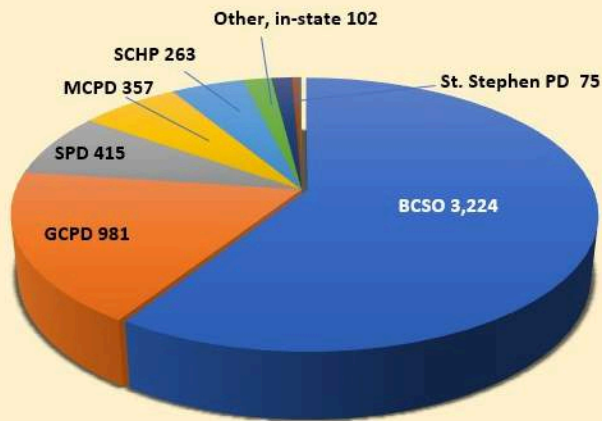

BOOKINGS BY AGENCY IN 2023

In 2023, 4,470 persons were booked into the Hill-Finklea Detention Center. The Berkeley County Sheriff's Office, accounted for 72% of all bookings in 2023. The top five agencies booking persons into the detention center are: the Berkeley County Sheriff's Office, the Goose Creek Police Department, the Summerville Police Department, the Moncks Corner Police Department, and the South Carolina Highway Patrol.

BERKELEY COUNTY SHERIFF'S OFFICE HILL-FINKLEA DETENTION CENTER



ADMINISTRATIVE DIVISION

The Administrative Division includes the Classification Unit, Records Unit, Training Unit, Policies and Budgeting, Property Management, and Contract Management.

CLASSIFICATION UNIT



The Classification Unit has two detention deputies that are responsible for evaluating incoming inmates for classification. The Unit tracks disciplinary procedures and provides monthly statistics regarding inmate disciplinary actions to the Hill-Finklea Detention Center Director.

RECORDS UNIT

The Records Unit is comprised of six civilians and one detention deputy. The Records Unit is tasked with records entry and management, inmate accounts, and management of the inmate files. These records include Jail Management System data, expungements, certain court records, and release records. Members of the Records Unit also are assigned victim notification responsibilities and serve as receptionists in the lobby area of the Detention Center. The Records Unit Sergeant is also responsible for supervising detention deputies that are assigned to the courthouse to supervise inmates at the court house and act as escort officers.



BERKELEY COUNTY SHERIFF'S OFFICE HILL-FINKLEA DETENTION CENTER

CONTRACT MANAGEMENT

The Administrative Captain coordinates contractor services to include: medical services, food services, inmate phone services, digital mail services, and video visitation.



TRAINING UNIT



All detention deputies are required to complete a minimum of 40 hours of training each year. The Training Unit ensures that the training is completed for each detention deputy and maintains all training records. The Unit is responsible for daily, weekly, and monthly internal inspections of life safety equipment. Training detention deputies are also tasked with PREA (Prison Rape Elimination Act) compliance and assist with the updating and reviewing of policies and post orders. The Training Unit consists of one Sergeant and one Administrative Assistant.

PROPERTY MANAGEMENT



The management of inmate personal property is an important role within the Detention Center. Currently, there is one detention deputy assigned to manage the property rooms.

BOOKING

Two civilian booking clerks assist with processing inmates and filing and also assist with operations at the front desk controls. With 4,470 inmates booked into the Hill-Finklea Detention Center in 2023, these clerks stayed busy.

MENTAL HEALTH PROGRAM

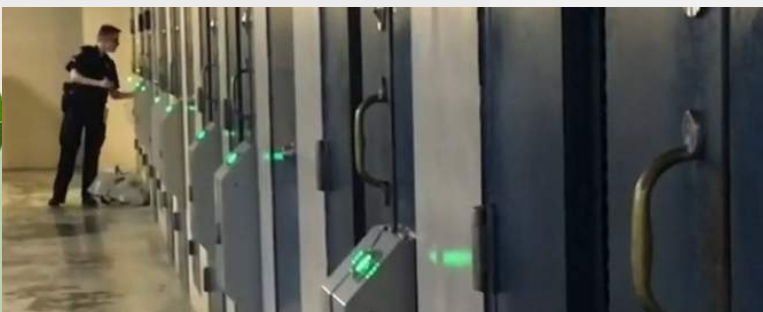
In 2022, through the combined efforts of Sheriff Duane Lewis and State Representative Sylleste Davis, Berkeley County was able to implement funding of \$378,000 through a pilot program facilitating a partnership between Hill-Finklea Detention Center and Berkeley County Mental Health. The state funding added a clinician and substantially increased the amount of time spent by Mental Health Service providers at the facility. The clinicians receive referrals from medical staff, detention deputies, and inmates themselves. This pilot program also provides mental health follow-up services after release and helps former inmates find employment.

As a result of the program's success in 2022, an additional \$ 400,000 was added to the pilot program for the year 2023, furthering mental health services and care for inmates incarcerated.

Significant findings from October, 2022-December, 2023 include:



- 92% of inmates evaluated by psychiatrist were prescribed medications
 - 38% of inmates evaluated have a serious mental illness
- A total of 3,731 services provided
- 1,776 MHP contacts

BCSO Captain (Retired) Will Rogers
End of Watch August 27, 2021

Captain Will Rogers passed away after a battle with COVID. Captain Rogers gave over 30 years of his life to service. In 2015, he survived an ambush attack in the line of duty that doctors never expected him to endure. Will was an outspoken advocate for the prevention of violence against members of Law Enforcement until his very last days.



BCSO Lieutenant Mark Tillman
End Of Watch September 27, 2018

Lieutenant Mark Tillman died unexpectedly on September 27, 2018. Lieutenant Tillman was serving as a Patrol Squad Lieutenant at the time of his death. He was a 26-year law enforcement veteran. He served with Berkeley County for 20 years.



BCSO Deputy Marion Eugene Wright
End Of Watch November 19, 2002

Deputy Wright had just finished his shift and was on his way home when he stopped to assist a disabled motorist with a flat tire. A City of Summerville Officer, William Bell, also stopped to assist Deputy Wright. As the officers were changing the tire, an on-coming vehicle left the roadway and struck both officers. Deputy Marion Eugene Wright and Officer William Bell were both killed. The section of highway where the tragedy took place was renamed William Boland Bell and Marion Eugene Wright Highway.



BCSODEputy Harvey L. Middleton
End Of Watch May 11, 1975

Deputy Sheriff Harvey Middleton was shot and killed when he and the St. Stephen Police Chief attempted to arrest a man on a shooting spree.



Magistrate Warren Calhoun Guerry
End Of Watch May 27, 1947

In the 1940's Magistrates still made arrests in their jurisdiction. Magistrate Guerry had arrested a suspect for robbery and was transporting him to a local constable's home when the suspect stabbed him with a knife. He succumbed to his injuries before other officers arrived on the scene.

Berkeley County Constable Robert Hasell -
End Of Watch February 4, 1893

Constable Robert Hasell was shot and killed while attempting to serve a warrant for trespassing. Two people were convicted of Constable Hasell's murder and were sentenced to death. Constable Hasell had only served as a constable for one day.
